Voters to decide on \$37.27 million budget proposal

CONTENTS

The Tri-Valley Central School District Board of Education adopted a 2024-25 budget proposal that prioritizes student achievement and responsible fiscal management while considering the impact on taxpayers.

Eligible residents will vote May 21 on the proposal, which maintains curricular, extracurricular and athletic programs and reallocates staffing while retaining the academic excellence the community expects of the district. The \$37,273,719 proposal represents a 2.13% increase over the current year's budget.

The adopted expenditure plan would offer educational programming that maximizes student engagement in core classes, electives and college credit opportunities while addressing student needs with assistance and enrichment.




With the elimination of federal pandemic relief funding sources, the district is proposing to incorporate the after-school enrichment program, various STEAM initiatives and software upgrades into its general operating budget. Supporting these programs in the general budget will prevent them from being cut.

The 2024-25 proposed budget aligns with the district's vision of building a community that enables students to excel in a changing world and staff to grow professionally and gives the opportunity for staff and administration to collaboratively reduce costs while continuing to meet students' needs.



BUDGET SUMMARY


All school districts are required to present the budget in three expenditure categories – Administrative, Capital and Program – and compare them to the previous year's budget totals. Tri-Valley's three-part budget breaks down as follows:

THREE-PART BUDGET	ADOPTED 2023-24	PROPOSED 2024-25
Administrative Component	\$3,684,206	\$4,047,686
Capital Component	\$4,337,749	\$4,487,574
Program Component	\$28,475,181	\$28,738,459
TOTAL BUDGET	\$36,497,136	\$37,273,719

The Administrative component includes all areas of the budget related to the administrative operations, including school and Central Administration expenses, Board of Education expenses, and all other administrative activities.

The Capital component includes maintenance of facilities, salaries and benefits of the Buildings and Grounds staff, debt service, and any monies for future maintenance and improvements to the school buildings.

The Program component, the biggest of the three components, includes all areas related to the instructional program. This includes teacher salaries and benefits, student support services, BOCES instructional programs, and all transportation operating expenditures.


